PUBLIC SUMMARY

The ALMA Board held its November 2023 meeting, at the Santiago Central Office (SCO), Chile.

The Board's Chair, Toshikazu Onishi, welcomed all Board members, assessors and attendees.

In addition to other matters during the meeting, the Board:

- 1. Reviewed the status of ALMA
- 2. Reviewed the status of Cycle 9 and 10
- 3. Discussed about ways to increase high-frequency observations with ALMA
- 4. Received the ASAC report from the ASAC Chair
- 5. Reviewed the status of the Wideband Sensitivity Upgrade
- 6. Approved the Band 8v2 receiver upgrade Phase 1
- 7. Approved the OSF Correlator Room Phase 1
- 8. Approved the Next Generation Observing Tool (NGOT)
- 9. Approved the 2024 ALMA Budget
- 10. Reviewed the status of ALMA Site Use Agreements and non-ALMA Projects
- 11. Approved the ALMA Director's self-appraisal
- 12. Approved the 2024 goals for the ALMA Director and Key Personnel
- 13. Appointed 5 new ASAC members

ALMA Overview and Cycle 9/10 update

The Board noted the presentation given by the ALMA Director, regarding the status of ALMA, including:

- Hiring of Norikazu Mizuno as Deputy Director of Operations, effective on July 1, 2023 and of Álvaro González as Deputy Director of Development, effective on January 2, 2024.
- General outcome of Cycle 9, with observing hours being the 2nd highest in ALMA history, even with a total loss of observing time of 641 hours due to the cyber-attack of 2022.
- Other JAO considerations, including Health, Safety, Security, and Environment related matters.

The Board noted the Cycle 9/10 update presentation given by the Deputy Director of Operations, including:

- Key achievements and operational highlights in Cycle 9
- New capabilities available and on-going challenges in Cycle 10
- Reprioritization of activities because of the on-going work related to the Wideband Sensitivity Upgrade (WSU)

Scientific Matters

The Board noted the presentations given by the Observatory Scientist, the Chair of the ASAC, and the Chair of the Board's Science Committee regarding:
